AN ORDINANCE adopting a combined annual; budget and appropriating such sums of money as may be deemed necessary to defray all necessary expenses and liabilities of the Westmont Park District, Westmont Illinois, for the fiscal year beginning June 1, 2014 and ending May 31, 2015 and specifying the objects and purposes for which such appropriations are made and the amount appropriated for each object or purpose.

BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS OR THE WESTMONT PARK DISTRICT, DuPage County, Westmont, Illinois:

Section 1. That the following sums, or so much thereof as may be authorized by law, be and the same are hereby set out as the annual budget and appropriated for the corporate purposes of the Westmont Park District for the Fiscal Year beginning June 1, 2014 and ending May 31, 2015, as hereinafter set out and attached hereto as Exhibit "A".

Section 2. The receipts and revenues of the said Westmont Park District derived from sources other than taxation and not specifically appropriated, and all unexpended balances from the preceding fiscal year not required for the purpose for which they were appropriated and levied shall constitute the General Corporate Fund and shall first be placed to the credit of such fund.

Section 3. All ordinances or parts of Ordinances that in any way conflict with the provisions of this Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
